Pursuant to the Operating Regulations of the Board of Directors of PTSC Quang Ngai;

Based on the Minutes of Vote Counting of the Members of the Board of Directors No. 14/BTH-DKQN-HĐQT dated 07/02/2026,

RESOLVED:

Article 1. Approve the contracts and transactions between PTSC Quang Ngai and related Parties as stipulated in clause 1 and clause 2 of Article 167 of the Enterprise Law 2020; clause 5 of Article 293 of Decree No. 155/2020/NĐ-CP dated December 31, 2020, as amended and supplemented by clause 84 of Article 1 of Decree No. 245/2025/NĐ-CP dated September 11, 2025, of the Government, and any amending, supplementing, or replacing documents, with the specific contents as follows:

1. List of contracts and transactions with related Parties, the relationship between the related Parties and PTSC Quang Ngai, the main contents and values of the contracts and transactions as per the attached Appendix. The total value of contracts and transactions with each related Party arising during the period will be stated in the semi-annual and annual Financial Statements of PTSC Quang Ngai.

In case of new contracts or transactions arising or amendments/supplements to contracts and transactions beyond the scope approved in the Appendix, the Director shall report to the Board of Directors for consideration and decision, or submit to the General Meeting of Shareholders for decision (if within the authority of the General Meeting of Shareholders).



2. Implementation period: Applicable to contracts and transactions arising in 2026 and subsequent years.

Article 2. The contracts and transactions in the attached Appendix are approved based on consideration of fairness and avoidance of conflicts of interest in contracts and transactions between the Company and related Parties in accordance with legal regulations and the Company's Charter.

Article 3. This Resolution takes effect from the date of signing. The Director is responsible for organizing the signing and implementation of the contracts and transactions approved in Article 1 in accordance with the Charter, internal Regulations and Policies of the Company, and ensuring compliance with legal regulations.

Article 4. Members of the Board of Directors, the Director, Deputy Directors, Heads of relevant Departments under PTSC Quang Ngai are responsible for implementing this Resolution.
